FOR THOSE WITHOUT JOBS AND HOMES, THESE MEALS ARE LIFE-SAVING. FOR OTHERS WHO WORK BUT STILL LIVE IN POVERTY, OUR MEALS HELP TO STRETCH LIMITED FUNDS. IN ADDITION TO OFFERING BASIC NUTRITIONAL SUSTENANCE, THE COMMUNITY MEALS DAY PROGRAM IS A WELCOMING PLACE WHERE CARING STAFF AND VOLUNTEERS GIVE EMOTIONAL SUPPORT AND A SENSE OF COMMUNITY TO THOSE WHO OFTEN LIVE ISOLATED LIVES, AND A LEAD NAVIGATOR TRAINED IN SOCIAL WORK HELPS GUESTS STABILIZE THEIR SITUATIONS AND TAKE STEPS TO MOVE TOWARD PERMANENT HOUSING AND SELF-SUFFICIENCY. SOME WHO COME TO THE SOUP KITCHEN WANT ONLY A MEAL; FOR OTHERS, THE PROGRAM BECOMES A SPRINGBOARD
